## **Modified Co-Rec Sand VB Rules 2021**

- **Spectators are discouraged. Teams must wait for their court to clear.**
- **Teams should leave immediately after their match has finished.**
- **Players shall sanitize their hands before and after each game (sanitizer will be provided)**
- **Only 1 game ball per court is provided. Teams must bring warm-up balls.**
- **We will switch sides between games, handshakes are discouraged.**
- **When at all possible, all participants shall practice social distancing.**
- **Masks are not required for competition. If you are not competing and are unable to socially distance yourself, masks are required.**
